

# PRIVACY POLICY

Welcome to OOO "Winance" (hereinafter referred to as "Company", "We", "Us" or "Our")!

The Company offers to take part in an investment project in the bookmaker market that has been developing rapidly recently.

Our Privacy Policy applies to all visitors, Users and other persons (hereinafter referred to as "Everyone", "Users", "You" or "Your"), who have the right to use such services.

The Privacy Policy is regulated through the collection, use, preservation and disclosure of information received from the Users of the Web site <https://winance.eu>

The Privacy Policy applies to the Web site and all contracts, services, and any programs available through winance.eu

The Privacy Policy establishes your rights and obligations.

If you disagree with the conditions established by the Privacy Policy, you are not entitled to use these services.

Sometimes we will offer you special functions that have some respective conditions in addition to the Privacy Policy. In such cases the conditions established for those functions will be applied in case of any contradictions with the terms of the Privacy Policy.

## 1. Personal data

We have the right to get the Users' personal data by various means that include but are not limited to the Users' visit to the Web site, answers to the questions, inquiries, as well as other activities, use of services, functions or sources available on our Web site. If necessary, the Users are required to provide their name and phone number. However, the Users have the right to visit our Web site anonymously. We collect the Users' personal data only if they wish to provide such data voluntarily. The Users have the right to refuse of providing their personal data, unless they intend to make certain activities on the Web site.

## 2. Non-personal data

winance.eu has the right to collect the Users' non-personal data every time when they connect with the Web site. The non-personal data may include the name of the browser, type of computer, Users' technical data, as well as communication tools such as the type of operating system, name of the Internet service provider, and other similar information.

## 3. Internet Cookies characteristics

Our Web site has the right to use cookies in order to optimize the User's work. The User's Internet browser stores the cookies characteristics on its hard disc taking into account the registration details in order to control the data. The Users at their own discretion can disable the cookies registration function or enable the function of sending a signal by changing the parameters of their Internet browsers. In such cases they should be notified that an error may occur in certain sections of the Web site.

#### **4. Methods of application of the collected information**

We are entitled to collect and use personal data of the User in order to:

#### **5. Ways to save the Users' data**

#### **6. Distribution of the User's personal data**

We are not entitled to sell or provide other individuals with the User's personal data on a temporary basis. We are entitled on the basis of the above mentioned objectives to provide our partners, proxies and advertisers with general demographic information containing personal information about our visitors and Users.

#### **7. Children' privacy policy**

winance.eu doesn't collect or store data on persons under the age of 18. The registration of such persons in order to use our services isn't allowed. Such services and their content are not provided for the children under the age of 18. If we know that we have received data from persons under the age of 18 without their parents' consent we have the right to delete such data immediately. If you are sure that we have data on persons under the age of 18, please, contact us.

#### **8. Applicable law and competence**

Getting access to our Web site you accept the fact that all questions related to its use and visiting are governed by the laws of the Russian Federation. The disputes that may arise are governed by the commission composed of the representatives of each Party. If the Parties don't reach agreement, the disputes will be resolved in the order stipulated by the legislation of the Russian Federation.
